- Cardinal Landscaping: Next year Cardinal will not cut the slope behind 1717-1731 when it is wet. This should help keep the slope looking good.
- Quickbooks: Mark made a motion to refund Heather Robertson \$375 for the 2018 annual fee for our accounting software. The motion was seconded and approved. This was approved via email but needed to be approved officially at meeting
- Vantage Hill: RA cited Vantage Hill for issues around their swimming pool.
